Introduction

Nottingham Civic Exchange is seeking to enhance the space and focus for colleagues to deliver policy and civic impact using an established and successful government fellowship model. We will be running an NCE Policy Fellowship project to pilot this approach working with up to three academics across any pathways in the new year (2023/24).

The NCE Policy Fellowships aim to provide a coaching opportunity to colleagues creating space and support to further their policy and/or civic ambitions helping them to build their skills, confidence and network to make a positive difference in society. The scheme is open to all School colleagues up to Associate Professor level. This project aims to strengthen knowledge exchange pathways, enhance impact, create connections and support new research, practice and scholarly opportunities. It is intended that this Fellowship offer runs for up to one academic year.

About Nottingham Civic Exchange

Nottingham Civic Exchange is Nottingham Trent University's think tank, established to maximise research, policy and practical impact by bringing together university expertise with partners seeking to address the needs of people, communities and organisations. Nottingham Civic Exchange acts as a resource to look at social science focused issues in new ways. This means facilitating debate, acting as a bridge between research and policy debates, and developing practical projects on a local, city and regional level. Since our launch in 2017 we embraced evidence, created debate and inspired change. We offer exciting new perspectives on historic issues.

Nottingham Civic Exchange is based in the School of Social Sciences at NTU and engages deeply with our departments and research expertise to deliver meaningful evidence-based change. We act as a navigator for partners to connect with our expertise and knowledge so please get in touch with your ideas.

Nottingham Civic Exchange Policy Fellowship

A successful policy fellowship will build on colleague's research, expertise and current external networks to take forward work on a specific policy challenge or challenges. Support from NCE will help to refine the specific challenge and approaches to engage with it. The topic and the factors surrounding it will inform the types of work that can be conducted and the sorts of conversations and engagement we will undertake. NCE will work with each Fellow to develop a plan for they year.

Alongside specific outputs designed into a workplan for the Fellowship NCE also expects each Fellow to write a summative blog for the NTU news pages to outline their experiences and learning which will be used to support future rounds of the Fellowship scheme.

This project will utilise NCE secured buy-out secured from our external projects to fund three policy fellowships. Each Fellowship aims to starts from the beginning of an academic term. An open application process for our academics has been created to ensure best fit for the fellowships and to support departments to manage their own staff development plans. Applicants are required to complete a short form that would need to be signed off by their line manager. This will be assessed by NCE who will recommend applicants for final decisions are made by NCE's Steering Group and a SET representative. To ensure equitable distribution of this scheme departments can only take one position per round.

What to expect as a policy fellow?

Successful applicant will develop a proposal together with NCE to ensure outputs and learning are timetabled to build a successful policy fellowship that fosters knowledge exchange and impact activities alongside tangible outputs for their fellowship.

Applicants would be required to plan their fellowship around a set of policy engagement activities and goals with some example activities being:

- hosting workshops/roundtables with policy makers
- creating and sharing policy briefs
- undertaking longer term impact and knowledge exchange planning
- stakeholder mapping and engagement
- publishing policy focused reports and blog outputs
- select committee submission

Flexibility will be built into the process due to the complex and at times chaotic nature of the policy making environment so plans outlined at the beginning will be outline and developmental.

Funding

The Policy Fellowship programme offers a development budget for each Policy Fellow to support attendance at events, to meet partners face to face and to host engagement activities with organisations and partners. We expect there to be a budget of up to £3,000 per Policy Fellow.

Assessment Process

The Nottingham Civic Exchange Steering Group (a committee made up of School and external colleagues) and a member of the School Executive Team will review all applications against the criteria outlined above. No department will be able to secure more than one Policy Fellow per round so the most promising candidate will be considered in the final decision-making process. Heads of Department will be consulted to ensure line manager agreement has been sought prior to participation. Feedback will be gathered and distributed to all applicants following the announcement of the selected colleagues. Not being put forward will not restrict NCEs capability to engage with applicants going forward.
