This document is specifically for incoming students who are United States citizens or eligible non-citizens, due to receive funding either through the Direct Loan program offered by the US Department of Education, or an approved private educational loan provider. The same cost of attendance will be used for private loan applicants, (minus standard origination fees). Please be aware processing times will differ between providers.

Preparing for University

When studying with us, we highly encourage students to be financially prepared before undertaking a course. This will help to ensure you have the best student experience, without money worries during your studies. We also encourage students to only borrow funding that they feel they require for their course, to minimise the amount of loan you will begin repaying once you have completed your course. We can increase a loan (if you are under the maximum Cost of Attendance) if your circumstances changed during your studies.

You can do this in part by ensuring you maximise 'free money' by exploring all potential Scholarship options to help reduce your borrowing:

International Academic Scholarships

The University's International Development team offer several scholarships to Undergraduate and Postgraduate international students, to help reduce the cost of Tuition Fees. Please be aware, you are expected to notify the Financial Aid Office of all scholarships you receive, although ordinarily the Financial Aid Office will be advised internally of any University awards granted.

Upfront Costs

All new and returning students **will not** receive any loan funding until **after** arriving in the United Kingdom and completing enrolment to the status of Fully Enrolled at the University. This is in line with regulations to prevent loan funds being claimed fraudulently. Most student's first payment will be shortly after October 1 2023. Some first-time undergraduate borrowers may also be subject to the 30-day delay through the Direct Loan program.

Therefore, there are expenses we advise students will likely have to pay before receiving their financial aid, these include (although may not be limited to):

- Initial travel to the United Kingdom and University,
- Student visa and NHS (National Health Service) surcharge costs for the full length of course, (Undergraduates will pay for all anticipated years of their course upfront),
- Deposits, or early instalments, for accommodation,
- Funds for basic living costs on initial arrival and for a couple of weeks before loan funds can be paid.

The University **will not** be able to aid in these upfront costs.

Accommodation (& Guarantors)

Whether you are looking at on campus (University provided) or off-campus accommodation, you can find some really helpful information about finding and securing accommodation on the [Accommodation](#) webpages. When securing accommodation, you may be asked to provide a UK based guarantor. This may not be possible if you do not have UK based family or friends in a position to do this and you may also not be in the position to pay a large portion of your rent upfront. If this is the case, our accommodation team do now have a partnership with [YourGuarantor](#), who can act as your guarantor (although please be advised they do charge a fee and are not a direct part of Nottingham Trent University).

Advance Payment (£3,000.00)

The only upfront costs that the University may be able to assist with is the £3,000.00 Advance Payment required from international students. For students whose loan is due to cover the full Tuition Fee, we can look to defer this cost to be paid through the loan funding. This option is only available where the **full** Tuition is due to be covered – otherwise an applicant will be expected to make this payment upfront themselves.

Tuition Fees

All Tuition Fees listed are **only** for the 2023-24 academic year. If the course you are studying is longer than a year, your Tuition Fee for subsequent years will be confirmed once announced centrally by the University. We use your actual Tuition Fee in the Cost of Attendance calculation.

Undergraduate Fees

- £16,500 or,
- £17,200 for courses in the Nottingham School of Art & Design and Nottingham Business School.

Any work placement years undertaken in 2023-24 will be charged £1,850 for the year.

Postgraduate Fees

Fees for Postgraduate courses are not universal across schools, as such, please refer to the above weblink to confirm the tuition being charged for your specific course of study.

Dual Citizens

Some UK and US dual citizens who meet specific residency criteria, prior to the start of their course, may be charged a lower 'home' Tuition fee. In this case for Undergraduates the lower Tuition Fee of £9,250.00 will be used in the assessment. Postgraduate assessments will include the home rate.

Tuition Fee assessment decisions are made by our [Admissions](#) team at the point of entry, and such decisions cannot be made or appealed by the Financial Aid Office. Ordinarily your Tuition Fee status will not change mid-way through the course, even if your residency changes. If you are eligible to receive funding from a UK Student Finance provider as well as applying for US Financial Aid, you will be asked to provide evidence of this funding to the Financial Aid Office, as it will count as financial aid that we must include when assessing your loan eligibility.

Living Allowances

In line with the US Department of Education regulations, a standard Cost of Attendance will be offered to all eligible student when calculating loans. The Cost of Attendance offered will be the **maximum** allowance for approving loans. As such, a student's own actual costs may be lower. Please note, these costs are based (as directed) on an average student, as such there may be more expensive options available, but these would not be considered 'average' student costs.

Undergraduate courses are typically assessed over 39 weeks and Postgraduate courses are typically assessed over 52 weeks (excluding some Art and Design Postgraduate courses which are only 45 weeks). Your actual course length will be used in our assessment.

Living Expenses

As accommodation on and off campus can be similarly priced in Nottingham, we do not have different allowances between on or off campus living expenses.

We allow a maximum weekly allowance of £220.00 per week for accommodation, utilities, and insurance. Plus a maximum weekly allowance for food (groceries and eating out) of £55.00 per week. This gives a maximum weekly allowance of £275.00 per week for living expenses.

For an Undergraduate student over 39 weeks, this would be £10,725.00. For a Postgraduate student over 52 weeks, this would be £14,300.00.

Transportation

Transportation includes an allowance of £2,500.00 for two return trips from the USA to the UK. Additionally, we include an allowance for travel between your residence, campus and (if applicable) your place of work at £10.00 per week. (This should cover an annual NCT Bus pass or Robin Hood travel card).

For an Undergraduate student, this would be £2,890.00. For a Postgraduate student, this would be £3,020.00.

Books, Course Materials, Supplies

Where no additional costs are advised on the course materials or by the course team, an allowance of £10 per week will be included.

For an Undergraduate student, this would be £390.00. For a Postgraduate student, this would be £520.00.

If the course information or team advises higher costs for books, printing, materials or trips, these will be included on a course-by-course basis.

Professional License

Some accredited courses may mean that a student can join a related society (e.g. British Psychology Society, Society of Forensic Science). Annual membership for these societies will be included on a course-by-course basis.

Miscellaneous Personal Expenses

For this section we would potentially include the following allowances:

General Allowance	For all students, at a rate of £40.00 per week. To cover other potential costs, e.g. clothing, homeware, entertainment, mobile phone contract, etc.
Visa Costs	Included for those joining NTU for their first year of study or anyone renewing due to change of studies. £363.00 included (the rate for applying outside the UK as of March 2023)
NHS Surcharge	Included for those joining NTU for their first year of study or anyone renewing due to change of studies. £470.00 per year, plus an additional 6-month allowance. (E.g., £1,645.00 for a 3-year Undergraduate course)
Computer Allowance	A once per course allowance of £1,000.00 (ordinarily in the first year) for laptop hardware/software costs.

Other Allowances

There are occasions in which the University **may** be able to include specific additional costs, **however a student will need to notify us to allow a review of the applicable costs a student would like us to include.** Potential examples of such costs are:

- Childcare costs (during contact hours), for students with dependents,
- Costs relating to a disability or ongoing long term medical/health condition.

For children, we are only allowed to childcare costs in your Cost of Attendance. We would ask a student to provide a copy of their child's birth certificate to confirm their age (this may impact the prices being charged and the level of childcare required).

Standard Origination Fees

A percentage origination fee is charged for all loan types by the US Department of Education and the fee taken from the gross total loan, so the University can only release a net amount of loan. (The gross and net loan amounts will be advised to you once your loan has been originated).

As such, we include an estimate of the standard origination fee a student will be charged to ensure they are still eligible to receive their full Cost of Attendance.

Worked Examples

Example: First Year Undergraduate Cost of Attendance

In 2023/24, the Cost of Attendance used is £1 = \$1.27. This example is assessed over 39 weeks.

In our example, for an Undergraduate student:

- they are in their first year of a 3-year BA(H) Fashion Design FT course,
- they have **been awarded £2,000** in Academic Financial Aid (scholarships),
- they require a visa and have asked to receive the computer allowance,
- they are a **dependent** student.

The student could borrow up to \$5,500.00 in Direct Loans. Up to the remaining \$39,915.00 could be explored either as a private loan application or a parent borrower could look to take out a Parent PLUS loan (credit dependent) on the student's behalf.

Students may not require their full Cost of Attendance.

Example: Second Year Undergraduate Cost of Attendance

In 2023/24, the Cost of Attendance used is £1 = \$1.27. This example is assessed over 39 weeks.

In our example, for an Undergraduate student:

- they are in their second year of a 3-year LLB Law FT course,
- they have **been awarded £1,000** in Sporting Financial Aid (scholarships),
- they do not have visa costs as they are a continuing student,
- they are a **dependent** student.

The student could borrow up to \$6,500.00 in Direct Loans. Up to the remaining \$34,803.00 could be explored either as a private loan application or a parent borrower could look to take out a Parent PLUS loan on the student's behalf.

Students may not require their full Cost of Attendance.

Example: One Year Postgraduate Cost of Attendance

In 2023/24, the Cost of Attendance used is £1 = \$1.27. This example is assessed over 52 weeks.

In our example, for a Postgraduate student:

- they are on a one-year course studying Digital Marketing,
- they have **been awarded £3,000** in Financial Aid (scholarships),
- they require a visa and have asked to receive the computer allowance.

The student could borrow up to \$20,500.00 in Unsubsidized Direct Loans. Up to the remaining \$29,782.00 could be borrowed through a Graduate PLUS Loan (credit dependent) or a private loan provider.

Students may not require their full Cost of Attendance.

Example: One Year Postgraduate Cost of Attendance

In 2023/24, the Cost of Attendance used is £1 = \$1.27. This example is assessed over 52 weeks.

In our example, for a Postgraduate student:

- they are on a one-year course studying Cyberpsychology,
- they have **been awarded £1,000** in Financial Aid (scholarships),
- they require a visa and but **do not** want to receive the computer allowance,
- they have a 2-year-old child they wish to put in childcare when studying.

The student could borrow up to \$20,500.00 in Unsubsidized Direct Loans. Up to the remaining \$36,984.00 could be borrowed through a Graduate PLUS Loan (credit dependent) or a private loan provider.

Students may not require their full Cost of Attendance.

Additional Information

- Private Loan applications will need to be completed with your preferred private loan provider. Nottingham Trent University **does not** have a preferred private loan provider and will work with any lender who is willing to work with Foreign Schools. We are aware that there are limited providers who do work with Foreign Schools, so can support any student who is have difficulties identifying a provider.
- Parent PLUS and Graduate PLUS Loans are an additional application process, which typically will not open until May 1 2023.
- A Financial Aid Offer is liable to change if there is any change to a student or their course's eligibility. Students would be contacted in this case to notify of any such amended.
