Successful students will receive a monetary award of up to £500 to cover the cost of their fees for their chosen virtual summer school course. This award money is provided by Santander Universities.

Application process:

- 1. Submission of this completed application form to <a href="mailto:summerabroad@ntu.ac.uk">summerabroad@ntu.ac.uk</a> including a weblink to the summer school you wish to apply for and the fee of the course.
- 2. You will be notified of the outcome of your application within 15 days of applying.
- 3. If successful you will be required to email proof that you have been accepted onto your chosen summer school course along with the fee (if possible) and a completed bank transfer form.
- 4. Once we have received your email we will forward your completed bank transfer form to our Finance Team for payment.

Requirements of the scholarship\*:

- 1. You must provide us with a copy of your payment receipt once you have paid the fee for your summer school course.
- 2. You must provide us with proof of completion of your summer school course this might be a copy of your certificate / an email from the summer school / transcript of results.
- 3. You must complete our summer school feedback form.

**Application deadlines:** scholarships will be awarded on a 'first come first served' basis and will be awarded until the 1<sup>st</sup> June 2021 or until the scholarship money runs out – whichever is soonest.
