

## Terms and Conditions for Regional OMBA Scholarships (ROMBA Scholarship)

1. To be eligible for a ROMBA Scholarship, you must have an offer of a place on an eligible course ((Online MBA (OMBA) including OMBA Data Analytics).
2. Please do not submit a scholarship application before you have applied to study at the University. You must have an offer of a place on an eligible course with NTU (Nottingham Trent University) before submitting a scholarship application.
3. These scholarships are for applicants from Africa, India, and the Middle East only. 4. Students who receive sponsorship (your tuition fees are being paid by an employer, government, or funding body in full or in part) are not eligible to apply for this Scholarship.
5. Applicants may only apply for a ROMBA Scholarship once per academic year per offer of a place on a qualifying course.
6. You are only eligible for a ROMBA Scholarship if you are due to enrol on the first year of a course in May 2022, August 2022 or January 2023. OMBA students enrolled before January 2022 and due to progress onto the second, third or fourth year of their course of study in May 2022, August 2022 or January 2023, or repeating the first year of study, are not eligible to apply.
7. Applicants must be a student starting a new course of OMBA study at NTU. We cannot consider applications from students who were enrolled on a course of study at NTU before January 2022, unless they are progressing onto a new course of study at NTU.
8. Applications received after the 16:00 GMT (4 pm) deadline will automatically be considered for the next available deadline. For example, application forms submitted after the first deadline and before the second deadline, will be considered for the second deadline.
9. Applications received after the final deadline will not be considered.
10. This application form is for eligible online postgraduate taught courses only. Please do not use this form to apply for research funding.
11. If you are awarded any other scholarship, bursary and / or tuition fee reduction from NTU you will only be eligible for the higher award
12. The ROMBA Scholarship is not transferable and will not be awarded if you choose to transfer to a different course of study at NTU.
13. Applicants will be informed whether they have (or have not) been awarded a ROMBA Scholarship (and of the value of the scholarship award if they have been awarded) within four weeks of the application deadline.

14. The scholarship is applied to the tuition fee when an applicant accepts their scholarship offer/ and accepts and meets the conditions of their course offer/ and is eligible to enrol on the course.

15. Scholarships are competitive, and selection is based on the information provided on the scholarship application form. It is particularly important that you give your scholarship statement careful thought and preparation, and that you refer to the criteria provided.

16. NTU's decision in all matters relating to the scholarship is final.

17. If your scholarship application is successful, we may ask you to become a student ambassador, or to appear in online and / or printed marketing materials for NTU. For example, providing a student profile and a photograph which may be used to promote NTU and NTU's scholarship schemes and courses. Your name and course will be printed in the Scholarships Awards Celebration scheme. 18. If you fail to complete your course and choose to retake the course or undertake another eligible course, any scholarship you were awarded will not be applicable.

19. If you fail to complete your course and the scholarship was not applied (i.e., you did not pay the tuition fees, or the tuition fees were reimbursed) then subject to the eligibility criteria, the scholarship may be available should you choose to retake the course or undertake another eligible course. You must re-apply for the scholarship.

20. If you withdraw from your course while owing a proportion of your tuition fees to NTU, application of the scholarship shall be at the discretion of NTU, and the scholarship may be withdrawn.

21. NTU may close scholarship applications to courses at any time where that course is full and closed to new applications.
