How to apply

- Direct entry **only** - no need to go through UCAS
- Entry criteria:
 - For 2+1 - average mark of 50 in your second year, with minimum of a pass mark in each module, we accept resits.
 - For 1+2 – average mark of 50 in your first year of UKT, with a minimum of a pass mark in every module, we accept resits.
 - IELTS 6.5 (5.5 minimum in each element)
 - No IELTS? We also accept C or above in 1119 English as well as other American, Australian, British and Canadian qualifications (any other qualification, please contact us)
