## Nottingham Law School sub-Saharan African LLM International Scholarship Guidance Notes / Supplementary application form

Nottingham Law School is offering **one** competitive scholarship up to the value of the international tuition fee (£15,100) for the academic year 2020/21.

- The scholarship is available to sub-Saharan African students, who are holding an offer of a place to study on a Nottingham Law School full-time LLM Masters programme (excludes professional courses such as the LPC/BTC).
- The scholarship will be awarded to the candidate who most closely meets the criteria for the award.
- The scholarship decision will be made by an awarding committee and all decisions are final. If you are awarded the scholarship, your tuition fee for 2020/21 will be waived.
- Applications must be submitted to international@ntu.ac.uk by 24 June 2020 16:00 GMT.
- If your application for the sub-Saharan African LLM International Scholarship is unsuccessful, you will automatically be considered for the half fee School scholarship and international scholarship.
- Applications must consist of a fully completed **International Scholarships Application form and this supplementary application form**, including a statement of 300 words for each of the criteria on the following pages. Please take great care completing the scholarship statement.

### 1. Demonstrate clear leadership capacity and illustrate a successful track record in a professional setting.

#### 3. How will you fund your living costs whilst at NTU?

• Give details of how you plan to fund your living costs while studying at NTU.

The NLS Africa Scholarship will cover the full amount of your tuition fees. Please note that you will need to be able to pay accommodation fees and other general living costs yourself. To get a Tier 4 student visa you will need to save £9,135 in a bank account in your name or your parents name for minimum 28 days to cover your living costs, plus any outstanding course fees for the first year of your course. If you are awarded this scholarship you will be asked to provide your bank statement to demonstrate proof of living costs.

#### Terms and conditions

#### Sub-Saharan Africa LLM International Scholarship

- 1. Applicants are only eligible to be considered for this scholarship award if they have been offered a place on a full-time LLM Masters programme (excludes professional courses such as the LPC/BPTC).
- 2. The scholarship will only be awarded once an applicant accepts their offer to study on an eligible programme.
- 3. Scholarships are competitive, applicants are required to complete the two application forms and address the selection criteria.
- 4. All scholarship applications must be submitted on or before Monday 24 June 2019 16:00 GMT (4 pm). Applications received after this date will not be considered.
- 5. Successful applicants will be notified of their award within four weeks of the closing date. If you have not had a response from the University in this time you should assume you have been unsuccessful.
- 6. The scheme is only open to sub-Saharan African students.
- 7. Sponsored students (full / part) are not eligible to apply for the scheme.
- 8. One scholarship of the international tuition fee for 2019 entry is available; the panel may choose to award a part scholarship.
- 9. Please note if you are awarded any other scholarship / discount from the University, the maximum awarded will not exceed the international tuition fee.
- 10. If you are awarded the scholarship, your tuition fee will be covered by the scholarship.
- 11. The scholarship is not transferable and will not be awarded if you choose to defer your entry to a different start date, or if you choose to transfer to a different course at the University.
- 12. The University reserves the right to revoke the scholarship if a student subsequently leaves the programme.
